### **1.0. BACKGROUND**

The National Airports Corporation Limited (NAC) is appreciative of the industry cooperation and understanding in respect to revise, introduce or amend its aeronautical charges to provide better services to its customers including the air operators.

In line with clauses 7.4 and 18.7 in the Conditions of Use (COU), NAC is exercising its right to vary all Aeronautical Charges.

As per the clause 18.7 the CPI rate to be used is the rate for the last Quarter in the preceding year prior to the adjustment date. The adjustment date as laid out in the COU is 01 April and the relevant CPI is that of 31 December.

### **2.0. NEW AERONAUTICAL PRICES – EFFECTIVE 01 APRIL 2024**

We are implementing and applying the CPI rate as at 31 December 2023 with a small rounding factor (see table below). The reported CPI for 31 December 2023 is 4.0% as per the link <http://www.tradingeconomics.com/papua-new-guinea/inflation-cpi>
