PROVISION OF LANDSIDE SECURITY SERVICES AT DARU AIRPORT

The National Airports Corporation of Papua New Guinea (NAC) invites experienced and qualified security firms to submit tender in providing comprehensive both Landside and Airside Security Services for DARU Airport, encompassing but not limited to; public safety and security at the Daru Terminal Area, staff residential area, the power house compound, general perimeter and the main accesses into the airport boundary.

Scope of Services:

The selected security contractor will be responsible for the following:

1. Providing around-the-clock security coverage for the specified areas, including the passenger Terminal building, Office, power house compound, and main access points to the airport.
2. Ensuring public safety within the car park area, implementing necessary measures to prevent any security breaches or incidents.
3. Conducting regular patrols, access control, and surveillance to maintain a secure environment.

Qualification Requirements:

Interested security firms must meet the following criteria:

1. **Certification:** Possession of necessary certification from the IPA, IRC & PNG Security (Protection) Industry Authority for the provision of security services.
2. **Financial Stability:** Demonstrable healthy financials and assets to support the assignment and taskings over the 12-month role.
3. **Personnel Training:** Provide documentation demonstrating the recurrent training programs and certifications of guard personnel in accordance with appropriate safety and security industry standards and regulations.
4. **Safety and Security Documentation:** Provide Documentation to show appropriate daily, weekly and monthly reporting, including necessary incident reporting templates or statements
5. Availability of resources to carry out the scope of services

Tender will be evaluated based on the following criteria:

1. Certification and Compliance with IPA, IRC and the PNG Security Council regulations.

3. Capacity of Immediate Supervision Team and Quality of Training of Personnel
4. Relevant experience in providing security services for similar sized clients or areas.
5. Proposed approach and methodology.
6. Availability of resources to undertake this task/scope
