Aircraft Pavement Strengthening, New Terminal Building & Associated Works at Hayfield Airstrip, Maprik District, East Sepik Province, Papua New Guinea.

1. The **Independent State of Papua New Guinea** has received financing from the Asian Development Bank (ADB) towards the cost of **Civil Aviation Development Investment Project II**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **National Airports Corporation** (“the Employer”) invites sealed bids from eligible bidders for the construction and completion of **Aircraft Pavement Strengthening, New Terminal Building & Associated Works at Hayfield Airstrip, Maprik District, East Sepik Province, Papua New Guinea** (“the Works”).

The Works comprises of the following:

- a) Runway, Turning Nodes, Taxiway and Apron Pavements Strengthening works;
- b) 2-Coat bituminous chip sealing to the aircraft movement areas;
- c) Construction of New Terminal Building and Carparking;
- d) Installation of Security Fencing;
- e) Other Associated Works.

3. **Open Competitive Bidding** will be conducted in accordance with ADB’s **Single - Stage: One - Envelope Bidding without Prequalification** procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

- Soundness of financial position over the last **three (3) years**;
- The Bidder must demonstrate that its financial resources, less its financial obligations for its current contract commitments, meet or exceed the total requirement for the Subject Contract of **USD\$ 0.38 million.**;
- Average Annual Construction Turnover (minimum) of **US\$2.31 Million per year**, within the last three (3) years;
- Construction experience and participation in at least one (1) contract within the last five (5) years with a value of at least **USD\$ 1.97 million** that have been successfully or are substantially completed by the Bidder and that are similar in physical size, nature of works, complexity, methods, and technology;
- For the above or other contracts executed during the last five (5) years, a minimum construction experience in the following key activities:
 - i) Basecourse Pavement Construction (over 1.2km of pavement length);
 - ii) Application of Bituminous Chip Sealing and/or Asphalt Pavement (over 1.2km of length); and,
 - iii) Building construction and installations for water, power and sewerage.
- The qualification criteria are more completely described in the Bidding Document.
